



AUTHORIZATION, RELEASE AND INDEMNIFICATION AGREEMENT FOR PRIVATE GOLF CART OWNERS

In consideration of the permission granted by the Louisville Parks and Recreation Department, Division of Golf to operate my privately owned golf cart on the public course, I promise and agree to indemnify and hold harmless the Louisville/Jefferson County Metro Government, the Golf Professional, and any of their employees from and against all claims, damages, losses and expenses, including attorney's fees, that may arise from or through my use of my golf cart, and to release the foregoing parties from liability for 1.) any injuries sustained by me while operating my cart on the public courses and 2.) any injuries sustained by any other party resulting from the use of my cart on property owned or leased by Louisville Metro government.

I also promise and agree to pay for any damages that are sustained to the public course which are caused by my privately owned cart, and obey all posted or written Louisville Parks and Recreation golf course policies.

I represent that I am familiar with the operation and use of my golf cart and that I can operate and control same and will do so in a safe manner. For safety and maintenance reasons only standard or ADA designed golf carts are allowed. Segways, utility carts, electric cars and other such vehicles are prohibited.

I also understand that no one under the age of 18 is allowed to operate my privately owned golf cart on Louisville Parks and Recreation courses, and I understand that only the driver and one passenger are allowed to ride in my cart at the same time.

I agree to pay trail fees per established and posted rates. Trail fee cost to be per rider or bag per 18 hole round or less.

I warrant that I have a minimum of \$100,000 liability insurance coverage for my operation of this golf cart under either my Homeowners Insurance policy or a separate policy.
